Please accept my sincere and warm gratitude for your kind invitation to address the participants in, organizers of and guests to the *International Conference on Cyber Law, Cyber Crime and Cyber Security – New Delhi 2015!*

Bulgaria and India enjoy cooperation agreements in the field of radio and television, between news agencies, between the unions of journalists, between the ministries of youth and sports, between Krustyo Sarafov National Academy for Theater and Film Arts and the National School of Drama in Delhi.

An Indian-Bulgarian Friendship Society operates in India; the Friends of India Club in Sofia is the publisher of *Svetilnik* magazine to which the Embassy of the Republic of India in Bulgaria kindly contributes.

Indeed India has many friends in Bulgaria who are fascinated by classical and modern Indian prose and poetry, by the miraculous symbolism of your historic and outstanding cultural monuments, by your nation and its powerful spirit and magnetic singularity.

In addition to my admiration for India I would like to express my professional respect to you, Mr. Duggal. Your career abounds in results that are to be attributed to your dedicated work. I congratulate you on your achievements as one of the pioneers and a leading expert in cyber law and intellectual property rights in an electronic medium; on your expert performance in the arbitration of disputes that are within the competence of the World Intellectual Property Organization, as an adviser at the Ministry of Information Technology, India's Government and other institutions on matters of cyber law and cyber crime and also regarding the Indian Information Technology Law of 2000.
